What sets Colleen's Child Care Apart from the Rest?

Colleen's Child Care DOES NOT CHARGE for days when the childcare IS NOT OPEN for business. You are charged ONLY for your contracted days that the childcare is open for business.

Child Care Fees

Weekly childcare rates as listed on the fees page are payable in advance and in full regardless of attendance, holidays, illnesses, or vacation days. Payment is due on Monday at the time of drop-off or the first scheduled day your child is here unless other arrangements have been made and are agreeable to both parties. Please make sure funds are available when the check is written. Payment through the app Zelle is preferred. Parents who qualify for the SCOE CAPP Program are responsible for the Parent to Provider Co-Pay to make up the difference between the program and my rates.

Extended Hours

If your child needs extended care – over 10 hours per day – there will be an added fee per day of \$10 added to your weekly rate.

Late Payment Fee

I have a "no pay no stay" policy. If payment is not received on Monday or on the first of each month if you choose to pay monthly or on the first scheduled day your child is here, a \$10 late fee will be charged daily in addition to that week's day care fees and your child will not be allowed to attend daycare. The reason for this is that I count on my income to pay bills that are necessary to operate the daycare not to mention pay my employees. This contract can and will be terminated at any time if payments are not made in a timely manner according to this contract or other agreement accepted by both parties.

Late Pick-Up Fees

If your child is picked up later than your scheduled time; a late fee of \$10 for the first 10 minutes or a fraction of 10 minutes plus \$1 for every additional late fee will be charged. These fees are payable before the child returns to care. The fee will be charged unless prior arrangements have been made and accepted by me. Late pick up is anything beyond the scheduled time that is determined at enrollment and entered on the enrollment contract.

Bounced Check Fee

If a check is returned to me for non-sufficient funds, you will be required to pay an added fee of \$35.

Family Vacations

I know that families may decide to take a vacation from time to time but to hold your child's spot at Colleen's Child Care payment must be paid for these days. Payment for the time your child will not be in care is to be given to the provider before you leave for vacation.

Provider Vacations, Personal / Illness Days and Holiday Closures

I will provide you with at least 2 weeks' notice for any vacation or personal days (i.e.: doctor appointments etc.) I may take. You will not be charged for days because my childcare is not open for business. You will be notified as soon as possible of any personal or family illnesses, funeral or emergencies and that day's care will be credited towards your next week thus reducing the amount of payment for the following week. I do my best to provide a calendar for the whole year outlining the days the childcare is closed.
